

NOTE: DO NOT TIGHTEN ANY CLAMPS OR NUTS UNTIL THE LAST STEP!!

- 1) REMOVE THE OLD EXHAUST SYSTEM. SAVE THE OLD FLANGES FROM THE ORIGINAL FRONT PIPE.
- 2) INSTALL THE LEFT (#3150-2, SINGLE BEND) AND RIGHT (#3150-1, 2 BENDS) MANIFOLD PIPES USING THE ORIGINAL FLANGES AND INCLUDED GASKETS. YOU WILL NEED TO USE YOUR ORIGINAL MANIFOLD STUDS AND NUTS. TIGHTEN ONLY ENOUGH TO HOLD IN PLACE.
- 3) INSTALL THE LEFT (#3150L-2, 8" AND 18" BEND LENGTHS) AND RIGHT (#3150R-2, 8" AND 15" BEND LENGTHS) FRONT EXTENSION PIPES TO THE MANIFOLD PIPES USING 2-1/4" CLAMPS. CLAMP LIGHTLY INTO PLACE.

- 7) MOUNT THE REMAINING LB7 HANGERS AND HARDWARE TO THE FRAME NEAR THE REAR EXIT LOCATION OF THE TAIL PIPES. CLAMP THE TAIL PIPES TO THE HANGERS USING 2-1/4" CLAMPS.
