OFF-ROAD RACE USE ONLY!! This product is not intended for use on public roads. It is recommended that the customer use MIL eliminator part number 129-1675, or equivalent, to avoid the vehicle from running improperly. This kit only to be used in conjunction with cat-back kit # 1028875, it will not bolt to stock.

Instructions:

DO NOT TIGHTEN ANY BOLTS OR CLAMPS UNTIL THE LAST STEP!!

1) Support the vehicle in a safe manner, using a shop hoist or frame contact jack stands on a level surface. Remove the oxygen sensors from the original H-pipe. Remove the original H-pipe and cat-back from the car, unbolting the system at the manifolds and at the clamps at the middle of the vehicle.

NOTE: you will need to re-use the manifold studs and nuts, and rear clamps to install this system.

2) Install the driver's side of the X-pipe (left front section) to the driver's side manifold, using the original hardware.

3) Repeat step 2) for the passenger side pipe.

4) Install the rear section X-pipe to the front sections, using 3" band clamps.

5) Install cat-back kit # 1028875, you will need to trim off the front portions of the cat-back where the tube is 2-1/2" i.d. (about 3"). The x-tube portion is longer and i.d. to make up this difference. Connect the rear sections of the X-pipe to the cat-back exhaust system using the remaining 3" band clamps.

6) Install the oxygen sensors to the appropriate oxygen sensor nut of each front section.

7) Tighten all clamps and bolts. Check for clearance, leaks and rattles.


