1) REMOVE THE EXHAUST SYSTEM AT THE FLANGES BEHIND THE CONVERTERS, LEAVING ONLY THE ORIGINAL CATALYTIC CONVERTER FRONT PIPES AND RUBBER MOUNTS ON THE TRUCK. YOU WILL NEED TO REUSE THE O.E. GASKETS AT THE FLANGES ALONG WITH THE ORIGINAL HARDWARE.

2) INSTALL THE LEFT AND RIGHT FRONT EXTENSION PIPES USING THE ORIGINAL GASKETS AND HARDWARE. THE SHORTER TUBE IS FOR THE DRIVER SIDE, LONGER TUBE FOR THE PASSENGER SIDE. ATTACH THE HANGER MOUNTS ON THE FRONT EXTENSION PIPES TO THE O.E. RUBBER HANGER MOUNT ABOVE. ATTACH THE H-PIPE SECTIONS USING A 2-1/2" CLAMP.

3) USE 2-1/2" MUFFLER CLAMPS TO ATTACH THE INLETS OF THE MUFFLER TO THE FRONT EXTENSION PIPES.

3) INSTALL THE INLET OF THE TAIL PIPE (THE END WITH THE SHALLOW BEND) TO THE OUTLET OF THE MUF-FLER USING THE FRONT 3" HANGER CLAMP (MULTI-BENDS ON THE WIRE HANGER).

4) INSTALL THE REAR SECTION OF THE TAIL PIPE USING THE REAR 3" HANGER CLAMP (SINGLE BEND ON THE WIRE HANGER). INSTALL THE WIRE PORTION OF THE HANGER TO THE O.E. RUBBER HANGER MOUNT ABOVE.

5) TIGHTEN ALL CLAMPS AND BOLTS AND CHECK FOR CLEARANCE OF THE FRAME, BODY, CHASSIS MEMBERS, AND BRAKE AND FUEL LINES.


